## Short term rental operators in Community Court (Bmail)...

Operating a short term rental (rental less than 30 days) without a proper license can result in fines up to \$500/day. Owners of four properties were fined \$50 and ordered to cease operations: 256 Lameuse St, 6268 Kimbrough Blvd., 1984 Todd Cove, and 4071 Licksillet Road.
