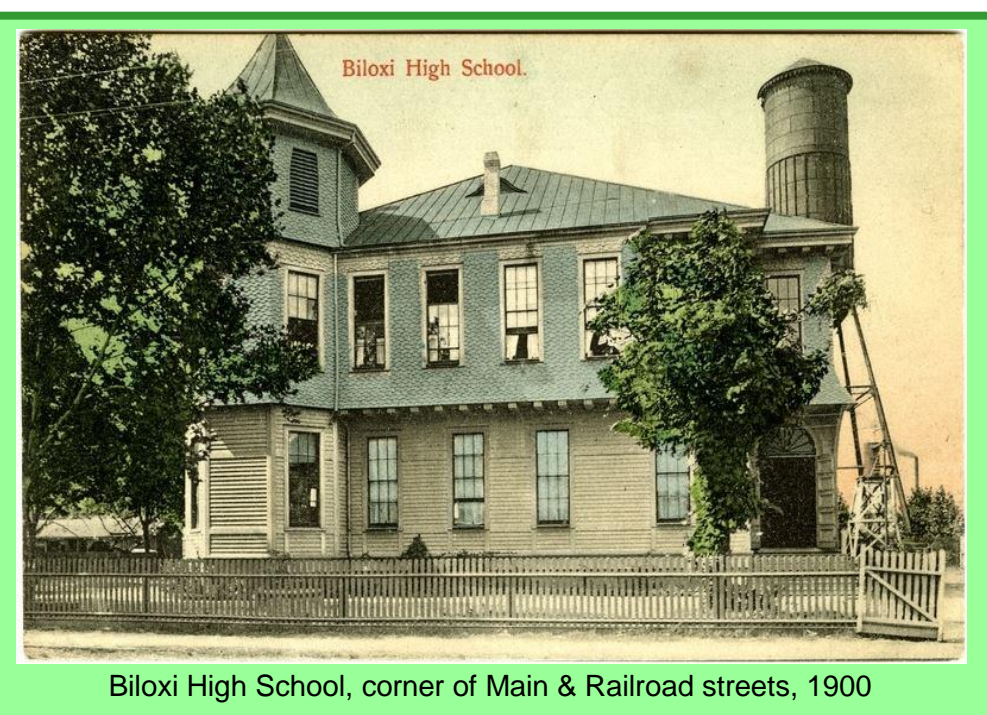

The Board of Supervisors is the governing authority for counties in our state. County priorities are set, projects funded, and the business of the county is conducted through the lawful actions of the board. The Board of Supervisors functions within the legislative and executive branches of government. ► Where your tax dollars go... a comparison of your FY2019 tax levies (millage) you pay if you live in Biloxi's city limits: City of Biloxi, 30.10 mills; Harrison County, 36.42 mills; Biloxi Schools, 43.37 mills or Harrison County Schools, 54.91 mills (depending on which school district you reside in; generally, Ward 7 is in the Harrison County School District, all other wards are in the Biloxi School District)
