Mississippi Power upgrading lights in Biloxi...

Mississippi Power Company has begun upgrading the approximately 3,000 streetlights in Biloxi to energy efficient light emitting diode (LED) fixtures. The work in Ward 5 is expected to begin at the end of March and last for a few months. You may notice crews working on Channel Mark Dr., Eastview Dr., Lakeview Dr., and Big Lake Road; please drive by any utility crews with care. Installing smart photocells that are integrated with a central management system will monitor the status of the new fixtures.
