The Mississippi State Department of Health (MSDH) will issue press releases for Boil Water Notices that they issue to radio, television, and newspapers in the affected area to supplement the public notification efforts by the city. Locally, Biloxi residents are notified by [Bmail](#) and [B-Alert](#); consider subscribing to both of these FREE city notification services. Typically, for a neighborhood water line break, the city issues a Boil Water Notice and signs are posted in the affected neighborhood(s).
