Payment of traffic tickets before court date...

Mississippi law allows you to prepay a traffic ticket prior to the court date. The back of the ticket has more information about doing so. Should you prepay, there is no need to report to court. *This is allowable only for tickets given at the scene without a formal arrest.* Some traffic violations require a formal arrest and booking; attendance at arraignments on Mondays are mandatory. Should you fail to appear on your plea date, your case will be set for trial. If you fail to appear for the trial, the case may be tried in your absence (TIA). If found guilty, your judgment and TIA letter will be mailed to the address in your court record and collection efforts will proceed.
