The proposed planned development-residential district master plan will create 62 residential lots for construction of townhomes upon 5.05 acres was recently approved by the Planning Commission. The site is between Rue Palafox & Rue Petit Bois, east of Eisenhower Drive. The proposed project will be before the city council in May for approval.

Traffic signal at Irish Hill Drive & White Avenue...

The traffic signal has been adjusted (since the White Avenue KAFB gate is now closed) so Irish Hill traffic has fewer traffic signal interruptions; a left turn arrow is required for White Avenue traffic at that intersection.
