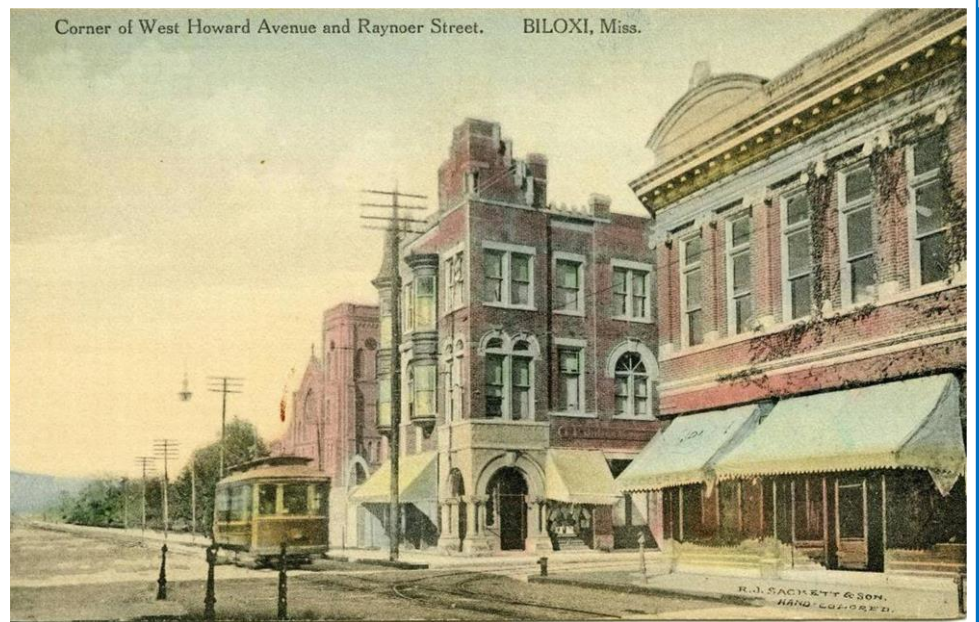

Residents on the east side of Pine Grove Avenue and the west side of Beach View Avenue recently received a letter from the City's Planning Commission about the 10-foot city easement that runs between those back yards. A public hearing on vacating that easement will be conducted Thursday, June 15, 2:00 pm at the Community Development auditorium.

Water lines on Big Lake...

Two contractors are working on Big Lake Road: one boring, the other to do water line work. They're switching water service line connections from the west side of Big Lake to the east side of Big Lake and replacing transite lines with pvc lines. This explains those tiny yellow flags you've seen.
