

#### Garbage & recycle Notice of Intent...

The Harrison County Utility Authority (HCUA) contracts with the cities of Biloxi, D'Iberville, Long Beach, Pass Christian and the unincorporated parts of Harrison County for garbage and recycling services. After advertising for bids and negotiations, HCUA has entered a new 6-year contract with Waste Management (garbage & recycling) and Pelican Waste (yard waste & debris). Based on the Consumer Price Index (CPI), the cost could increase annually a minimum 1% to a maximum of 5%. This first year, the city intends to increase the garbage fee \$6.75/month, from \$17.00 to \$23.75. This fee increase has publishing requirements, that is, you'll see this increase advertised in the local newspaper. This matter will be voted on by Council in September. <u>Read the July 25th Resolution</u>

#### Spratley Avenue update...

This drainage repair and resurfacing project is a joint City/County effort; county road crews are currently paving other streets in Biloxi and will move to Spratley Avenue in the next few weeks, according to the City engineer.
