## Popp's Ferry Road extension progresses... [See the affected area](#)

The project is divided into four segments: Segment 1- Popp's Ferry Road from US90 to 700 feet north of Pass Road; Segment 2- Pass Road from 800 feet west of Popp's Ferry Road to 600 feet east of Popp's Ferry Road; Segment 3- Coliseum Entrance Road from Popp's Ferry Road to the Coliseum property; Segment 4- US90 from 300 ft. west of new Popp's Ferry Rd to 800 ft east of new Popp's Ferry Road. The CXS/railroad easement must be approved by MDOT (Mississippi Department of Transportation) before the project moves forward. It's too early to project a bid date. This project's estimated cost is \$20M.
