Comprehensive re-zoning proposed in Ward 1... [List of zoning districts](#)

It was standing room only at Thursday's Planning Commission meeting for a public hearing and to learn more about a Comprehensive Zoning Map Amendment charged by the City Administration to the Planning Commission to consider changing sections of East Biloxi (594 parcels throughout Ward 1) that are currently zoned [RS-5](#) to [RM-30](#), [CB](#) & [WF](#), and also certain [RM-30](#); [LB](#); [NB](#); and [I](#) to [CB](#)-Community Business & [WF](#)-Waterfront. Maps were on display in the Community Development auditorium prior to the meeting. ▶ The matter was Tabled and a Planning Commission Workshop scheduled for Thursday, August 13, 2:00.
